You may or may not need to file it with your city, county, or state. It depends on your state's regulations. You may only need to fill it out and keep a notarized copy on hand.

How to Arrange Temporary Guardianship for a Child

Guardianship of the estate A guardianship of the estate is set up to manage a child's income, money, or other property until the child turns 18. A child may need a guardian of the estate if he or she inherits money or assets. In most cases, the court appoints the surviving parent to be the guardian of the child's estate.
