HIPAA Release Forms, or Medical Records Release Forms, are used by covered entities in accordance with the HIPAA or the Health Insurance Portability and Accountability Act of 1996, which has a privacy rule that inhibits the disclosure of patient health information without a written authorization form signed by the patient.

A "user" is defined in § 164.304 as a "person or entity with authorized access." Accordingly, the Security Rule requires covered entities to assign a unique name and/or number to each employee or workforce member who uses a system that maintains electronic protected health information (e-PHI), so that system access and activity can be identified and tracked by user.
