An EIDL loan, which is also referred to as an SBA 7(b)(2) loan or an SBA disaster loan, is available for certain entities that have been substantially impacted by COVID-19. As part of the CARES Act, EIDL loan applicants can receive a \$10,000 emergency grant within three days of application, through December 31, 2020.

Even if you have an existing SBA loan, you can still apply for an SBA COVID-19 Economic Injury Disaster Loan.
