In the Karnataka Tax on Professions, Trades, Callings and Employments Act, 1976(Karnataka Act 35 of 1976) in subsection (3) of section 5 for the words “within thirty days of - the receipt of the application” the words “within three days of the receipt of the application” shall be substituted.

Karnataka Professional Tax. Individuals with a gross annual income of less than Rs. 2,50,00 are exempt from tax. As per the Karnataka Professional Tax Slab Rates, all individuals earning a monthly gross income of more than Rs. 15,000 are subject to a professional tax of Rs. 200. The state government collects professional tax on the gross income from individuals working as government employees or in private and non-government organizations (NGOs).

According to the proviso of item (xi) of section 94 of the Karnataka Municipalities Act, a tax under item (ix) shall not be levied where the Municipality levies of profession tax. As professions tax is now being levied in all cases, item (ix) of the proviso thereto of the Karnataka Municipalities Act are being deleted.
